The Q&A Telegram channel that you have referred to me again is locked and does not allow questions or comments to be submitted by group members. I have asked the question in the ANA group as you have also requested and was referred back to you by a member who goes by the name "James Faith".

The member who goes by the name "James Faith" advised me that your answers and advice are "**wrong**" and referred me back to you for official clarity.

Can you clarify my last point of confusion please? Is there an actual document called "Resident Declaration" which I have electronically signed?

I fully agree with you that documents should be read and understood, as a meeting of the minds should occur, prior to execution. I just didn't realize exactly what documents were linked to the signature form. I don't see where any of that was apparent. At time of signing the Resident Declaration, my perception was that I was agreeing with the text on the page preceding the signature form, specifically:

*Responsibilities of the resident*

*The residents will have to form their own assembly.*

*Self governance and self determination*

*The Government of The United States of America is not responsible for the residents of the States. The original State is responsible for its own residents.*

There is only one occurrence of the word compact on the page:

*This condition frees the residents of the States to form their own compact and adhere to their State constitutions without Manhattan Island interference.*

I thought I was agreeing to write my own compact in alignment with the guidance expressed on the form I signed all the way up to the moment when you advised me that I had agreed to multiple other documents with my signature. I'm still struggling to find or discern this in what was originally presented to me.

Thank you for your help. Once I have my answer regarding the existence of a Resident Declaration document, I believe I'll be up to speed and ready to continue forward.

Once you have earned +100 Continental Dollar LB, or purchased them with crypto, you can make payment for Naturalization and Related Delivery Service. Click on the link 'Buy-Exchange-Transfer-Vouchers' and then the link 'Transfer Money to Others'. You will put in the amount '100' and transfer to 'Treasury'. Create a ticket here: [continentalpublicbank.com/support](https://continentalpublicbank.com/support) . Please put your name and amount paid in the comments box.

Once payment has been made the treasurer will notify this office and we will then send you a link with a password for proceeding with your naturalization.
